

# **Colorado Works Change Coming: New First-Level Sanction Amount**

Who: All Individuals Who Participate in Colorado Works Workforce Development

## What: New First-Level Sanction Amount

Starting in June 2023, the Colorado Works (CW) Workforce Development (WD) first-level sanction amount will change from a 25% reduction in the Basic Cash Assistance (BCA) grant to \$1.00. Second and third-level sanction amounts and percentages will remain the same, and a fourth-level sanction will result in a case closure for one month.

First Second Sanction: 25%

Second Sanction: 25%

Third Sanction: Sanction: Case Closure

Sanction Level	Penalty Period	OLD Benefit Reduction	NEW Benefit Reduction
First-level	One month	25%	\$1.00
Second-level	One month	25%	25%
Third-level	One month	25%	25%
Fourth-level	Case closure	100%	100%

Note: It is important to urge clients to engage in the program regardless of the sanction level or benefit reduction.





## **Colorado Works Change Coming:** New First-Level Sanction Amount (continued)

## Why: House Bill 22-1259

On June 3, 2022 the Colorado State Legislature passed House Bill 2022-1259 (HB 22-1259), also known as the Temporary Assistance to Needy Families bill. This act made several changes to the Colorado Works program, including reducing first-level sanctions to \$1.00.

## How: Look for the following changes in Colorado Benefits Management System:

- Wrap-Up Screen
  - The Wrap-Up screen will display a difference in the reduction amounts.
- Notice of Action

A new notice of action letter and reason code will be triggered for cases with a first-level sanction.



### Your Cash Assistance benefits have changed.

#### More about your Cash Assistance benefits

- You didn't complete at least one (1) of the steps that you told your case manager/coach you would do or that you said you would do in your Individualized Plan (IP).
- You also haven't given good cause.
- You need to contact your case manager/coach as soon as possible to find out what you need to do to cure, and then serve this sanction.
- If you don't correct this problem, your case may close or remain closed, and your household won't be able to get benefits.

#### Note:

- These changes only apply to the CW program and will not impact other high-level program
- The <u>CW Re-engagement process and flow</u> remain the same.

When: These changes will go into effect June 1, 2023.
