AF GLOSSARY

AND-CS: Aid to the Needy Disabled - Colorado Supplement is a program which supplements people who received less than the full amount of SSI up to the SSI maximum income limit

AND-SO: Aid to the Needy Disabled - State Only is a program that provides interim financial assistance to people who are awaiting approval for SSI

BENDEX: Interface for Title II benefits: SSA retirement, SSA disability, and SSA Survivors benefits

Collateral Contact: Verifying customer information via a 3rd party knowledgeable about a household situation. Examples include employers, landlords and telephone calls to banks or life insurance companies

CSV: Cash Surrender Value refers to life insurance. This is the amount that would be received if the policy was immediately surrendered

Deeming: Counting income of a non-recipient spouse or parent toward a customer. Refer to 3.534, 3.544, and 3.549 for more information on deeming.

Disregards: Income deductions allowed for Adult Financial programs.

DMV: Division of Motor Vehicles

Encumbrance: Valid and legal outstanding payments, loans or liens upon a resource

Fair Share: Fair Share refers to shelter costs. It is calculated by adding the total rent and utilities for the household and then dividing by the number of people living in the home

Fleeing Felon: An individual who is fleeing to avoid prosecution, custody, or confinement after conviction of a felony

FMV: Fair Market Value is the value of a resource based upon what a knowledgeable, willing, and unpressured buyer would pay for the resource to a knowledgeable, willing and unpressured seller

FV: Face value means the value stamped or printed on the resource verification (insurance policies, bonds, stocks, etc.) which represents the future potential worth of the resource but does not always represent the true current value of the item.

Grant Standard: Maximum Adult Financial grant payment that can be provided to a customer based on each specific Adult Financial program

HCA: Home Care Allowance is a program which provides additional funds to an Adult Financial customer on SSI or AND-SO to pay for non-skilled services to help that customer maintain independence

IM-14: This is the Interim Assistance Agreement form used for AND-SO which allows for recovery of AND-SO payments from the first retroactive SSI payment received by the customer

In-kind Income: Something received of value that is not money, such as free shelter, bartered goods, etc.

Interim Assistance: A payment from the State to a person awaiting approval for SSI benefits. In Colorado, these people receive AND-SO as their interim assistance payment

Irrevocable: Cannot be altered, changed, or reversed

ISM: In-kind Support and Maintenance is income for certain customers who are not paying their fair share of shelter costs

IEVS: The Income Eligibility Verification System is an interface that matches income in the customer's CBMS case with CDLE, BENDEX, and SDX income

Look back period: Period of time transfers without fair consideration affect eligibility. For Adult Financial, the look back period is 36 months

Marriage: For AF programs, marriage can be common law, a civil union, or traditional marriage

Med-9: A form used for AND-SO which is completed by an authorized medical provider to report the type and duration of the customer's disability

NRS: A Non-recipient Spouse is a customer's spouse who is not receiving Medicaid or Financial Assistance

NRP: Non-recipient Parents are parent(s) of a minor child who are not receiving Medicaid or Financial Assistance

OAP: Old Age Pension for those age 60 or older. Who meet all financial and non-financial eligibility requirements.

OAP-HCP: Old Age Pension Health Care Program - State funded Medical Assistance for persons on OAP who do not qualify for Medicaid

PARIS: Public Assistance Reporting Information System which provides a data matching process by which states can match customers of human services and Medical Assistance programs with rosters from the Department of Defense, Veteran's Services and other states' public assistance

PNA: The Personal Needs Allowance is a payment to persons who are institutionalized with income under the PNA standard. It allows customers to pay for items which are not covered by the institution such as cell phone bills, newspaper subscriptions, or haircuts

PPP: Prudent Person Principle means that, based on experience and knowledge of the program, the county department exercises a degree of discretion, care, judiciousness, and circumspection, as would a reasonable person, in a given case

Resources: Assets owned by an individual or household

Revocable: Can be altered, changed or reversed

SAVE: The Systematic Alien Verification for Entitlement interface is a federally mandated data transmittal system to ensure that non-citizen documents are valid

SDX: Interface for SSI Income

SSI: Supplemental Security Income from Social Security

SSN: Social Security Number

SVES: The State Verification Exchange System is a federal/state interface that receives verification of a customer's social security number, citizenship, and other personal data used to establish eligibility for public assistance

Title II: Social Security benefits other than SSI

Title XVI: SSI

TWFC: A Transfer Without Fair Consideration is a transfer of ownership of a resource in which the value received is less than the actual value of the resource

UIB: Unemployment Benefits

USCIS: United States Citizenship and Immigration Services
