Project 14967 — CW Pregnancy Logic Updates

Unknown Pregnancy End Date

CW will now assume that a pregnancy has ended 30 days from the Pregnancy Expected Due date if a worker does not enter a pregnancy end date. When the Expected Due Date is 30 days in the past, EDBC will be run through a Mass Update process and CBMS will apply a 10+1 day timely noticing from the date of the EDBC run (treated as the date reported/verified). The Pregnancy Allowance will stop after the timely noticing is given.

Example

- Jaylen has a son and is expecting twins on 06/28/2021. She was so busy caring for her new family that she forgot to report when her babies were born, so no end date for the pregnancy was entered in the pregnancy screen.
- On 07/27/2021 (30 days from the Expected Due Date), CW will assume that the pregnancy has ended.
- The 11-day timely noticing will start on 7/27/2021, 30 days after Jaylen's expected due date.
- The Pregnancy Allowance will end effective 09/2021.
- A Speed Letter will be sent out to Jaylen 20 days after the Expected Due Date to remind her to report the end of the pregnancy or the birth of a child.

Known Pregnancy End Date

When the actual pregnancy end date is entered by a worker, Timely Noticing will be applied to end the pregnancy allowance from the date the client was required to report that their pregnancy ended (the 10th of the month following the change).

Example

- The doctor told Yen and Luka that their first baby will be born on 11/15/2021. They get approved for CW and start receiving the pregnancy allowance.
- They are very excited and call their worker right away to report the birth of their newborn, early, on 11/5/2021.
- Since the pregnancy end date is known to CBMS, the 11-day timely noticing period will start from the date the change was required to be reported.
- Yen and Luka were required to report the birth of their child by 12/10/2021. The pregnancy allowance will end
 effective 01/2022.



'No Eligible Child'

After the pregnancy ends, if no baby is added to the case, the pregnancy allowance will stop. If there are no other eligible children, the case will fail for 'No Eligible Child'. These actions will not happen separately. CBMS will process both at the same time.

Example

- In the evening of October 27, 2021, Wilda was born. For her safety, it was determined in the hospital that she needed to be removed from her family the same day, so the child welfare caseworker notifies the CW program of the birth and removal of the child. Wilda's mother will stop receiving the pregnancy allowance.
- The CW case will also close as there are no other children in the home.
- Timely noticing will be applied starting on November 10, 2021, the date when the change was required to be reported. The pregnancy allowance will stop, and the case will close in 12/2021.



Alternative Timely Noticing

Timely notice from the date the client was required to report pregnancy ended.
