

CBMS MA Overdue Pregnancy Records

Reviewing and updating pregnancy records that have passed the Expected Due Date with no Pregnancy End Reason entered.

Pregnancy End Section (on Pregnancy page)

Workers should only use the correct selectable Reason (Abortion, Miscarriage, New Born or Overdue) and Source to ensure members receive the correct 12 months of their post partum period.

The selectable options of "Overdue" and "State Report" are only selectable when a record is registered as over 365 days old.

The only time the selectable options of "Overdue" & "State report" should be used is in two instances:

1. If the record was already closed with this reason and source and the worker is making an update to the already existing record.
2. If counties are working their Over Due Pregnancy records report and the member can not be reached to update the record (these are only records that are 365+ days old).

If Pregnancy End Reason is “Overdue” and Verification Source is “State Report”
an informational message will appear:

“By selecting this end reason, the member will not be entitled to postpartum benefits.”

Data Conflict Record (on Run EDBC page)

When a case has a pregnancy record with an expected due date that is 15 days or more in the past and the worker runs EDBC, the system will generate a data conflict with the reason “Pregnancy Record Overdue.” The Data Conflict record contains a hyperlink to the Pregnancy screen so that the user can navigate back to the Pregnancy screen and update the Pregnancy Record.

All Pregnancy Records should be reviewed and updated as needed to ensure that members are in the correct category of Medical Assistance.
