

# NON-CITIZENS - ACCEPTABLE DOCUMENTS AND CLASS CODES

## IMMIGRATION STATUS & DESCRIPTION

### **Afghan Humanitarian Parolee**

Afghan citizens and nationals paroled into the U.S. between July 31, 2021, and September 30, 2022, and their spouses, children, parents, or guardians paroled after September 30, 2022. Clients with this status are considered qualified non-citizens until March 31, 2023, (or the term of parole, whichever is longer).

### **Asylee**

Individuals who meet the legal definition of refugee, but who apply for asylum status after they are already present in the U.S. or at a port of entry. Individuals who have a pending application for asylum are not eligible for services (unless Cuban or Haitian).

### **Battered Non-Citizens**

Battered non-citizen spouses or children, non-citizen parents of a battered child or non-citizen children of a battered parent with a petition pending. Eligibility varies depending on circumstances.

### **Certain Amerasians From Vietnam**

Individuals from Vietnam who were admitted to the U.S. as immigrants, were born in Vietnam between 1/1/1962 and 1/1/1976, and were fathered by a U.S. citizen. There are few, if any, new arrivals in this category.

### **Certain American Indians Born Abroad**

American Indians born in Canada living in the U.S. under §289 of the INA or non-citizen members of a Federally recognized Indian tribe under §4(e) of the Indian Self-Determination and Education Assistance Act.

### **Conditional Entrants**

Granted conditional entry under §203(a)(7) of the INA as in effect before 4/1/80.

### **Cuban Or Haitian Entrant (Parole)**

Individuals granted parole status as a Cuban or Haitian or granted any other special status for nationals of Cuba or Haiti; any other national of Cuba or Haiti who was paroled and has not acquired another status under the INA, is the subject of exclusion or deportation proceedings under the INA, or has an application for asylum pending with DHS/USCIS; and (2) With respect to whom a final, non-appealable, and legally enforceable order of deportation or exclusion has not been entered. Cuban/Haitian Entrants are sometimes referred to as 'Entrants.'



# NON-CITIZENS - ACCEPTABLE DOCUMENTS AND CLASS CODES

## IMMIGRATION STATUS & DESCRIPTION

### Deportation or Removal Withheld

Individuals whose deportation has been withheld under §243(h) of the INA as in effect before 4/1/97, or whose removal has been withheld under §241(b)(3) of the INA.

### Hmong Or Highland Laotian Tribal Members

Individuals lawfully residing in the U.S. who rendered assistance to the U.S. Military in Vietnam between 08/05/1964-05/07/1975 (rare). Includes the spouse (or unmarried surviving spouse) and unmarried dependent children of these individuals.

### Iraqi Or Afghan Special Immigrant Visa Holder (SIV)

Iraqi or Afghan individuals who have been employed by, or on behalf of, the U.S. government who are now in danger and who were granted Special Immigrant Visa (SIV) status. Families may also be granted SIV status. Iraqi and Afghan SIVs are Legal Permanent Residents (LPR) upon admission to the U.S.

### Lawfully Permanent Residents (LPRs)

LPRs are holders of green cards. This category also includes Amerasian immigrants as defined under §584 of the Foreign Operations, Export Financing and Related Programs Appropriations Act of 1988.

### Parolee

Individuals paroled into the U.S. under § 212(d)(5) of the INA for at least 1 year.

### Refugee

Individuals paroled into the U.S. under § 212(d)(5) of the INA for at least 1 year. Individuals outside of their nationality or, in the case of a person having no nationality, outside any country where they last habitually resided, and who are unable or unwilling to return due to persecution or a well-founded fear of persecution on account of race, religion, nationality, membership in a particular social group, or political opinion.

### Ukrainian Humanitarian Parolee

Ukrainian citizens and nationals, as well as non-Ukrainian individuals who last habitually resided in Ukraine, paroled into the US between February 24, 2022 and September 30, 2023 due to urgent humanitarian reasons or for significant public benefit. The status may also be given to spouses, children, parents or guardians paroled after September 30, 2023.



# NON-CITIZENS - ACCEPTABLE DOCUMENTS AND CLASS CODES

## IMMIGRATION STATUS & DESCRIPTION

### Victim of Trafficking

Individuals who are subjected to (1) Sex Trafficking, which is the recruitment, harboring, transportation, provision, or obtaining of a person for the purpose of a commercial sex act, in which a commercial sex act is induced by force, fraud, or coercion, or in which the person forced to perform such an act is under the age of 18 years; or (2) Labor Trafficking, which is the recruitment, harboring, transportation, provision, or obtaining of a person for labor or services, through the use of force, fraud or coercion for the purpose of subjection to involuntary servitude, peonage, debt bondage or slavery.
