CBMS Updates to MA Incarceration Logic Project 13751

Medical Assistance (MA) eligibility is impacted when a member becomes incarcerated. Most member will qualify for limited benefits while incarcerated. Currently, CBMS will terminate full MA benefits for certain MA benefits for certain MA primary aid codes as of the day prior to the date the member was incarcerated and begin limited benefits as of the incarceration date. Clarification was received from CMS indicating that full MA benefits should end as of the date the member becomes incarcerated. This project will change the current logic in CBMS to comply with this clarification and ensure appropriate noticing is provided to the members when the benefits are reduced or terminated.

- MA primary aid coded that allow limited benefits while incarcerated will terminate full benefits as of the incarceration date and begin limited benefits the day following the incarceration date.
- MA primary and secondary aid codes that do not allow limited benefits while incarcerated will terminate as of the incarceration date.

Currently, CBMS will terminate full MA benefits for primary aid codes on the day before a member was incarcerated and activates limited benefits on the date incarceration begins.

This can cause coverage issues in CBMS if the member has expenses before they are incarcerated.



With the updates made in this project, the med span is being adjusted forward one day. Now, if a member is on a primary aid code that allows for limited benefits, full benefits will continue through the date of incarceration.

Limited benefits will begin thefollowing day.

A member who has been receiving MAGI Adult since 2/1/19 and becomes incarcerated on 4/14/20. Full benefits would end on 4/14, and limited benefits begin on 4/15.

Changes to Noticing

There will be updates to the notices that will be triggered when a member is not eligible for benefits due to incarceration.

Denial Notice

There is a new denial NOA that will be triggered when an applicant is denied because they are incarcerated and are not on an allowable aid code.

Termination Notice

There is a new termination NOA that will be triggered when an applicant is terminated because they are incarcerated and are not on an aid code that provides limited benefis.

Change Notice

The existing change notice will continue to be send, and will now reflect limited benefits beginning that date following incarcertion.
